Sub: Appointment of technical consultants for techno economic feasibility studies for redevelopment of Railway stations

Instructions have been issued vide ref(3) above that the Zonal Railways may engage architectural consultants for preparation of Detailed Project Report (DPR) for stations where consultants had not been engaged by RLDA and other relevant instructions have been issued vide ref(1) to ref(5). As a follow-up to the instructions issued vide ref(3) above, RLDA and IRSDC had circulated the list of stations to Zonal Railways vide ref(6) and ref(7) above respectively.

2.0 In continuation to the above instructions, the list of stations earlier entrusted to IRSDC/RLDA where IRSDC/RLDA has not engaged consultants and some new stations are attached herewith as Annexure-1 for necessary action by the Zonal Railways. RLDA shall continue with the techno-economic feasibility study of stations where part studies had been done in the past by IRSDC/RLDA.

3.0 Cost of consultancy for the stations assigned to Zonal Railways shall be charged to "Major upgradation of stations on Indian Railways(Umbrella Work 2021-22)(Item No. 2/Supl/Dec 2021)".

4.0 Due care may be taken for identification of plots for commercial development of Railway land while the techno economic studies are carried out. Suitable consultation may be done with RLDA during the planning process.
