- In the event of requirement of additional spares other consumables costing over and above the quoted amount, the same shall be supplied by the contractor free of cost.
- Actual block working hours would be calculated & documented on daily basis in hard copy signed by Purchaser (Zonal Railway) and Supplier representatives.
- Initial batch of spares, costing upto 30% of the total accepted budget for spares **under Item No. 4**, would be supplied with the machines. Balance spares shall be supplied in installments, as per the experience gained in the field / actual requirement. All such spares shall be kept in the custody of consignee Railway. The railway shall issue such spares to the machine as per the operation & maintenance requirement of the machine.

**3.0 Terms & Conditions:**

All terms and conditions are as per tender. Some of the important conditions are as under:

2	Taxes & Duties	All the prices mentioned in above are basic rates and exclusive of all Taxes & Duties. Taxes & Duties, as applicable at the time of actual supply, shall be to the account of the purchaser subject to other tender conditions.
3	Foreign Exchange Variation	Variation in Foreign Exchange Rate shall be to the account of the Purchaser subject to other tender conditions.
4	Statutory Variation Clause	Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw material thereof), within the original delivery period of 22 months, or


