Delivery Period: All above mentioned Mechanical Spares shall be delivered the ultimate consignee destination within 12 months from the date of placement of order.

Statutory Variation Clause : Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw material thereof), within the original delivery period of 12 months, or last unconditionally extended delivery period shall be to Railways' account. Only such variation shall be admissible which takes place after the submission of Bid i.e. 21.11.2019. No claim on account of Statutory Variation in respect of existing tax/duty will be accepted unless the tenderer has clearly indicated in his offer the rate of Tax / Duty considered in his quoted rate. No claim on account of Statutory Variation shall be admissible on account of misclassification by the supplier/contractor

Other terms and conditions

Payment Terms: As per tender Clause 11.0 of ITT.

Liquidated Damages: LD shall be levied @ $\frac{1}{2}\%$ of price of the stores, per week or part of the week during which delivery is accepted subject to the upper limit of 10% of the value of the contract, irrespective of the delays (Para 2.0 of SOR).

Inspection: As per Clause 22.0 of GCC and Clause 11.0 of SCC. Inspection will be carried out by the Purchaser or his nominee at Consignee Depot or at any suitable place having proper testing facility, as decided by the purchaser.

Warranty: As per tender Clause 9.0 of SCC.

Performance Guarantee Bond & Warranty Guarantee Bond: PBG shall be submitted as per tender Clause 21.0 of GCC.


All other terms and conditions shall be as per subject tender.

As per Clause 21.0 of GCC, you are required to submit a Performance Bank Guarantee of value USD 231228/- (USD Twenty Three Lakh One Thousand Two Hundred Twenty Eight only), being 10% of the value of the contract with validity of 18 months (DP of 12 months + 6 months) within 30 days of issue of Letter of Acceptance.

The issuance of this acceptance letter shall be deemed to have concluded the contract. Detailed contract will be issued subsequently on submission of Performance Bank Guarantee in terms of the subject tender conditions.
