Prices: GST shown in the above table is as quoted by the firm. Actual rate of GST at the time of supply or as quoted by tenderer, whichever is lower, shall be payable. The above basic unit prices are firm and shall not be subject to variation on any account during currency of the contract.

Delivery Period: All above mentioned TCTTs shall be delivered FOR destination within 10 months from the date of placement of order.

Statutory Variation Clause : Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw material thereof), within the original delivery period of 10 months, or last unconditionally extended delivery period shall be to Railways' account. Only such variation shall be admissible which takes place after the submission of Bid i.e. 21.08.2019. No claim on account of Statutory Variation in respect of existing tax/duty will be accepted unless the tenderer has clearly indicated in his offer the rate of Tax / Duty considered in his quoted rate. No claim on account of Statutory Variation shall be admissible on account of misclassification by the supplier/contractor

Other terms and conditions:

Payment Terms: As per tender Clause 11.0 of ITT.

Liquidated Damages: As per tender Clause 19.0 of GCC.

Inspection : As per Clause 22.0 of GCC of the tender. Inspection will be carried out by the Purchaser or his nominee. Normally place of inspection in case of indigenously manufactured items shall be the Manufacturing Premises. However consignee shall have the liberty to carry out inspection at the Consignee Depot OR at the Place of Manufacturing. In case of imported items, inspection shall be carried out a Consignee Depot or at any suitable place having proper testing facility, as decided by the Purchaser.

Warranty: As per tender Clause 9.0 of SCC.


Performance Guarantee Bond (PBG) & Warranty Guarantee Bond (WBG) : PBG shall be submitted as per tender Clause 21 of GCC and WBG shall be submitted as per tender Clause 9.0 of SCC.

All other terms and conditions shall be as per subject tender.

As per Clause 21 of GCC, you are required to submit a Performance Bank Guarantee of value ₹ 1,89,83,309/- (₹ One Crore, Eighty Nine Lakh, Eighty Three Thousand, Three Hundred Nine only), being 10% of the value of the contract with validity of 16 months (DP of 10 months + 6 months) within 30 days of issue of Letter of Acceptance.

Kindly acknowledge this Acceptance Letter. The issuance of this Acceptance Letter shall be deemed to have concluded the contract. Detailed contract will be issued subsequently on submission of Performance Bank Guarantee in terms of the subject tender conditions.
