14.	All other Terms & Conditions	As per Tender Document.

You are required to submit a Performance Bank Guarantee of value ₹ 24,39,51,130/- (₹ Twenty Four Crore Thirty Nine Lakhs Fifty One Thousand One Hundred Thirty only), being 10% of the value of the contract with validity of 26 months (DP of 20 months + 6 months) as per Clause-21 of GCC.
