1.	Price basis and Price Variation:	PVC as per tender Cl. 9.9 of ITT is admissible only on the basic machine price i.e. ₹ 2,67,89,550.00/- only. All other prices of the contract shall be firm.
2.	Taxes & Duties	All the prices mentioned in above are basic rates and exclusive of all Taxes & Duties. Taxes & Duties, as applicable at the time of actual supply, shall be to the account of the purchaser subject to other tender conditions.
3.	Statutory Variation Clause	Statutory Variation in taxes and duties, or fresh imposition of taxes and duties by State/Central Governments in respect of the items stipulated in the contract (and not the raw material thereof), within the original delivery period of 38 months, or last unconditionally extended delivery period shall be on Railways' account. Only such variation shall be admissible which takes after 11.06.2019. No claim on account of Statutory Variation in respect of existing tax/duty will be accepted. No claim on account of Statutory Variation shall be admissible on account of misclassification by the supplier/contractor.

12.	Commissioning	As per Clause 11.0 of SCC to be read with Clause 8.3 of Technical Specifications .
13.	All other Terms & Conditions	As per Tender document.

As per Clause 21 of GCC, you are required to submit a Performance Bank Guarantee of value ₹ 15,30,56,190/- (₹ Fifteen Crore Thirty Lakh Fifty Six Thousand One Hundred Ninety only), being 10% of the value of the contract with validity of 44 months (DP of 38 months + 6 months) within 30 days of issue of Letter of Acceptance.
